

**Jackson County Historic Preservation Commission
National Historic Preservation Month Art Contest
May 2026 Guidelines- Submissions Due April 15, 2026 by 4:00 p.m.**

The Jackson County Historic Preservation Commission invites residents of Jackson County to participate in the **2026 Historic Places Art Contest**. This contest celebrates National Historic Preservation Month in May and encourages everyone to explore their local history and artistic talents.

Contest Overview

In honor of National Historic Preservation Month, this art contest invites residents to create a visual representation of a historic structure or place that is meaningful to their community. Participants are encouraged to consider historic buildings, structures, or places in Jackson County that are important to the identity of their town or community. Examples include:

- Historic buildings like schools, libraries, community centers, houses, and bridges.
- Public spaces such as cemeteries, parks, memorials, and green spaces.

The **2026 contest is open to all residents** of Jackson County, North Carolina. The finalists and/or winners will be featured in a public art exhibition within the County. Winners will receive special recognition and prizes, with the number of prizes determined by the total number of entries.

Eligibility

Open to all **residents of Jackson County, NC**.

- Submissions must represent historic places in Jackson County that are at least **50 years old**.

Submission Guidelines

- **Two-dimensional Artwork**
 - **Artwork Size:** Artwork must not exceed **11 x 17 inches** (poster size). **Free Poster Size Paper Located at the Jackson County Planning Department**
 - **Medium:** Artwork must be created on paper (no stretched canvas). Acceptable mediums include:
 - Pencil, ink, charcoal, acrylic paint, pastels, and other similar media.
 - Collage is permitted as long as the components are created by the artist.
 - Other creative approaches such as textiles.
- **Photography Artwork**
 - **Artwork Size:** Artwork must not exceed **11 x 17 inches** (poster size).
 - **Medium:** Acceptable mediums include:
 - Digital or film photography (color, B&W, sepia or toned, infrared, etc.)
 - Basic adjustments and editing are allowed (cropping, contrast, exposure, color correction, sharpening, noise reduction)
- **Three-dimensional Artwork**
 - **Artwork Size:** Artwork must not exceed **11 x 17 x 12 inches**.
 - **Medium:** Artwork must be built or sculpted. Acceptable mediums include:
 - Clay/ceramics, wood, stone, metal, plaster, mixed-media, and other similar media.
 - 3D printed works are not permitted.
- **Originality:** All artwork must be original. No reproductions, copies, or electronically generated artwork will be accepted. Participants should not trace, duplicate, or copy from published sources or photographs.
- **Artwork Presentation:** Entries must not be framed, under glass, or have any protective covering attached. Chalk or pastel pieces can be sprayed with fixative to prevent smudging. Photograph pieces can be matted.

Entry Form

- Each submission must be accompanied by a **completed entry form**.
- The **entry form** must be firmly attached to the **back of the artwork** using glue or tape.
- **Important:** No names, signatures, or identifying marks should appear on the front of the artwork. The artist's name should be printed **neatly on the back** of the artwork, in case the entry form becomes separated.

Judging Criteria

Judges will evaluate submissions based on the following criteria (K-5th, 6th-9th, 10th-12th, and Open Division):

- **Visual Impact:** How well does the artwork draw the viewer's attention? Consider the use of color, composition, and creativity.
- **Originality:** Entries should reflect the participants individual artistic expression and a unique interpretation of a historic structure or place.
- **Historical Relevance:** The artwork should illustrate a historic place or structure in Jackson County that is at least **50 years old**. Participants should aim to highlight how the place contributes to local identity or history.
- **Effort and Participation:** How the artwork shows exceptional effort, planning, and pride.
- **Understanding Achievement Completion:** The artwork is exceptional understanding of project requirements. Assignment followed and completed.
- **Craftsmanship:** The artwork is done with exceptional care and attention to detail and neatness.
- **Creativity:** The artwork is exceptionally unique, detailed, and interesting. Takes creative risks.

Awards and Recognition

- **Grand Prize Winner:** The winning artwork will be prominently displayed within the **County** as part of a public art exhibition in May 2026. The grand prize winner will also have their artwork featured on the **Jackson County Historic Preservation Commission's Facebook page**.
- **Finalists:** A selection of finalist pieces will be chosen for display in the exhibition.
- **Certificates and Publications:** All participants will receive a **certificate of participation**. Artwork from the contest may also be published in **informational materials** produced by the Jackson County Planning Department or Historic Preservation Commission.

Terms and Conditions

By submitting artwork, participants agree to the following:

- **Ownership:** The Jackson County Planning Department and/or Historic Preservation Commission retains ownership of all artwork submitted to the contest and may use the artwork in informational materials, publications, and public displays without compensation. All artwork will be returned to participants once the duration of the exhibit is over.
- **Liability:** The Jackson County Planning Department and/or Historic Preservation Commission is not responsible for any loss or damage of entries. Every effort will be made to safely return artwork to the artist following the contest.
- **Publicity:** Winning artwork and selected entries may be used in future publications, promotional materials, or online content related to Jackson County's historic preservation efforts.
